## WHAT IS RPC STAFF-FACILITATOR TRAINING?

RPC Staff-Facilitator Training is a comprehensive train-the-facilitator event for the National Child Traumatic Stress Network's Caring for Children Who Have Experienced Trauma: A Workshop for Resource Parents curriculum. This training is provided by staff at the Center for Child & Family Health and is sponsored by the NC Division of Social Services. RPC is a trauma-informed, 16-hour in-service training that has shifted the way foster, adoptive, and kinship parents work with youth. The curriculum is publicly available, but can be complicated to deliver to parents. Experts in RPC will help Staff-Facilitators-in-Training fully understand the curriculum content; provide feedback on their delivery of RPC; and provide ongoing consultation as Staff-Facilitators-in-Training teach RPC to parents in their community.
